**Sub: Intimation under Regulation 30 & 51 of SEBI (LODR) Regulations, 2015**

Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that Safetrunk Services Private Limited, a wholly owned subsidiary of PVP Ventures Limited, has been struck off by the Registrar of Companies, Chennai.

While an approval email was received from the Registrar of Companies (ROC), no formal certificate evidencing the striking off was issued. On the advice of our Practising Company Secretary (PCS), we raised multiple tickets with the Ministry of Corporate Affairs (MCA) for issuance of the Certificate of Striking Off. However, despite several follow-ups, the certificate was not issued by the ROC.

Subsequently, we approached our PCS once again. After conducting the necessary due diligence and verifying that the name of the company stands removed from the records of the ROC, the PCS has issued a certificate confirming that Safetrunk Services Private Limited has been struck off in toto. This certificate has been taken on record by the Company for its internal documentation and compliance purposes.
